### Climate change and agriculture

- Increased donor funding for the agricultural sector and new policy developments (CAADP, AGRA etc.)
- Growing focus on linkages between climate change on agriculture
- Climatic change adding to other stressors, giving increasing risks to food security, MDG achievements, and human wellbeing
- But also new opportunities for agriculture (low carbon development)
- Expectations of increased funding for adaptation and emission reductions (REDD+, adaptation funds)
- "Climate smart agriculture" as a driver for more sustainable land management and increased food security?

# Many different actors, with different starting points, interests and goals ...

- External policy agendas driving national policies and actions on the ground?
- Are policies informed by grounded research?
- Potential policy conflicts, within the agricultural sector and between agriculture and other sectors?
- Who are the actors, whose priorities are winning, and whose are losing?
- Are we learning from lessons from the past, or repeating old mistakes?
- => Need a better understanding of processes of policymaking ...


## Understanding policy processes on climate change and agriculture: two initiatives

- Research to Policy for Adaptation, RPA (funded by the DFID/IDRC CCAA programme)
  - Aims to increase the ability of CCAA programme partners in East Africa to understand climate change adaptation policy processes at local and national level
  - Case studies in Kenya, Tanzania, Malawi
  - · Policy analysis and engagement strategies
- Climate Change Theme, Future Agricultures Consortium (funded by DFID)
  - Building on the RPA project, aims to understand how international policy developments on climate change play out in the agricultural sector at national and subnational levels
  - Case studies in Kenya and Ethiopia
  - Research and policy analysis, stimulating debates and further work across the agricultural sector





- Policy processes as non-linear and "messy"
- Three lenses to help understand policy processes
- Focus on *policy spaces* as entry points for influence
